You have been issued a citation with Wayne County Justice Court. Please read your options below.

****Some violations require a Mandatory Court Appearance, please contact the Court clerk to schedule a court date.**

Option 1: Contest the Charges

To contest the charges, please contact the court within 14 days to set up a court date. You will be required to attend all proceedings in person or appear by Webex.

Option 2: Pay Fine

If you choose to pay the fine, the bail will be forfeited and the case will be closed. You can make payments online, by check, money order, or in person at the Courthouse.

ONLINE PAYMENTS: If you would like to pay your citation online, please follow the QR Code below. It will take you to the IntelliPay Portal. Please fill out your information and include your Citation # in the note field. **OR** visit utcourts.gov (make a payment / Justice Court / enter Citation # / follow link) This website will tell you the total amount due. You will receive a receipt upon payment from the Courts system.

Failure to do so can result in:

1st warning, 30 days adds \$50.00

2nd warning adds \$70.00 suspends Drivers License and may result in a Warrant of Arrest issued.
